____ My dog must have been evaluated to ensure she/he is not aggressive toward people or other dogs.

____ My dog's current Rabies & DA2PP vaccine records must be furnished to Indigo Ranch, LLC. Current flea & tick prevention is also required.

____ My dog must be spayed or neutered unless younger than 6 months of age.

____ My dog must wear a collar or harness with ID securely attached at all times while at Indigo Boarding.

CLIENT AGREEMENT AND RELEASE OF LIABILITY

I hereby release Indigo Ranch, LLC., its agents, officers, sub-contractors, employees, animal owners, customers, and potential customers of Indigo Ranch, LLC., from any and all liabilities, financial, and otherwise, for injuries to myself, my dog, or any other property of mine, which arise in any way from services and/or products provided by or as a consequence of my association with Indigo Ranch, LLC. I agree to assume all liabilities and responsibilities, financial and other wise, for the behavior and health of my dog(s). In consideration of the services rendered by Indigo Ranch, LLC., I waive any and all claims, actions, or demands of any nature, foreseen or unforeseen, that I may have against Indigo Ranch, LLC., relating to the care, control, health, and/or safety of INDIGO RANCH, LLC., my dog(s) arising during pick-up, transport, drop-off, and stay at the facilities.

I authorize Indigo Ranch, LLC. to do whatever they deem necessary for the safety, health, and well-being of my dog while under the care of Indigo Ranch, LLC., including seeking professional veterinary treatment for my dog. I agree to pay all costs and charges for any professional veterinary care obtained for my dog(s) during the time my dog(s) are in the care of Indigo Ranch, LLC. Due to the many outstanding benefits of dog socialization and Indigo Ranch, LLC., commitment to the safety and well-being of my dog(s), I agree that the benefits of dog socialization outweigh the risks.

I understand that Indigo Ranch, LLC., has the right to refuse service to me and/or my dog at any time for any reason. I understand that if my dog has a history of or repeatedly demonstrates aggression or biting of humans or animals, Indigo Ranch, LLC., reserves the right to refuse service. I understand that all bites will be reported to the local authorities as required by law.

I hereby declare to Indigo Ranch, LLC., that I am the legal owner of my dog(s). I further declare that my dog(s) has (have) not been exposed to distemper, rabies, or parvovirus within the past thirty (30) days; that my dog(s) has (have) been inoculated as indicated by records presented.

I agree that my dog(s) will not leave Indigo Ranch, LLC. until all charges have been paid to Indigo Ranch, LLC. I further acknowledge that if I fail to redeem my dog(s) from Indigo Ranch, LLC. within ten days of my scheduled date of pick-up, it is assumed that I do not intend to redeem my my dog(s) from Indigo Ranch, LLC., and I will be relinquishing ownership of my dog(s) to Indigo Ranch, LLC. Indigo Ranch, LLC. will additionally reserve the right to collect any monetary damages from me.

By signing below, I acknowledge that I have read this Boarding Agreement in its entirety and agree to all terms. This agreement shall be binding for a period of ten (10) years from the date of signature below.
